- You can give all or a portion of what remains after gifts to other beneficiaries, such as your family and friends, have been made, or,
- Your gift can be contingent upon special circumstances or events.

GIFT LANGUAGE FOR YOUR WILL

When making or revising a will, we encourage you to obtain the assistance of a legal professional. The following are suggested forms for making various types of gifts by will for the benefit of PBS KVIE:

1. Outright gift in your will

(a) Specific dollar amount:

I bequeath \$______ to KVIE, Inc., a California nonprofit corporation, for its general uses and purposes.

(b) Specific property (personal property):

I bequeath <DESCRIPTION OF PROPERTY> to KVIE, Inc., a California nonprofit corporation, for its general uses and purposes.

(c) Specific property (real estate):

I devise all of my right, title, and interest in and to the real property located at <DESCRIPTION OF PROPERTY> to KVIE, Inc., a California nonprofit corporation, for its general uses and purposes.

(d) Percentage of estate:

I devise and bequeath _____ percent (%) of my estate to KVIE, Inc., a California nonprofit corporation, for its general uses and purposes.

(e) Share of, or entire residue, of estate:

I devise and bequeath (all/or %) of the remainder of my property to KVIE, Inc., a California nonprofit corporation, for its general uses and purposes.

2. Conditional gift in your will

Insert the conditional language in one or more of the above provisions. For example: If (one or more individuals) does not survive me, I bequeath the sum of \$______ to KVIE, Inc., a California nonprofit corporation, for its general uses and purposes.
